Meeting Minutes

CALL TO ORDER

Doug Sphar, Chairman, called the meeting to order at 6:05 PM. It was noted that a quorum had been expected, but had not yet arrived.

MINUTES

February 8, 2018

Clarification was provided that the February 8, 2018 REAC minutes had been erroneously distributed as being approved during the August REAC meeting, but a quorum was not available during August. These minutes will be presented again at the next available opportunity. A REAC meeting was not held during the month of May.

Crane Creek Sanctuary Public Access Plan

Pine Island Conservation Area (PICA) Public Access Plan

It was determined that it would be best to wait until the next meeting to provide the information regarding the Pine Island Conservation Area.

Additional Discussion – Difficulty in Maintaining a Quorum at Meetings

The group discussed their frustrations regarding the lack of a quorum during the last three meetings. It was noted that even though the Committee has some members who do not regularly attend and there are currently three openings, a dedicated core group has previously been available for meetings and until recently maintaining a quorum has not been a continuing issue. It was also noted that one member had to resign recently, and another of the core group had extenuating circumstances which prevented them from attending the current meeting. Staff expressed their appreciation for the efforts of those in attendance.

It was noted that the guidelines for the REAC indicate that the group should meet quarterly and as needed. Additional meetings may be scheduled for a while in the future as it is anticipated that multiple public access plans will be reviewed during 2019.
