<u>STAFF REPORTS:</u>

CDBG Construction Project Updates: Charles (Ed) Wright provided an update on all current construction projects and provided the Citizen's Advisory Committee with a CDBG Project Status List Report for the month ending July 2024.

<u>The Sharpes Greenway Design</u> will provide an access path for children and parents to Bernice Jackson Park from North Railroad Avenue cul-de-sac, the Community Center, and avoid US HWY 1. Provide lights along the path.

Update: Project has been completed and a certificate of completion received from the Brevard County Building Department.

<u>The Sharpes Sidewalk Design</u> is to construct a sidewalk along Canaveral Groves Blvd., from Morris Avenue to the railroad tracks. The sidewalk will provide an access path for children and parents along the main road.

Update: Our engineer is proceeding with right of way permit; Engineer was also notified of concerns about large trucks driving over sidewalk.

<u>Demolition</u>: This will address the reduction of slum and blight countywide.

Ed discussed ADA Accessible Bus Stops within strategy areas. He is currently working with Space Coast Transit. The bus stop projects will be starting Oct. 1st with completion within a year.

Public Service Project Updates: Lee Vang assisted with providing the Committee a status report for the month ending July 2024.

One of the committee members mentioned the 0% expended for the contract period of 10/1/2023 – 9/30/2024 for Family Promise. Lee stated the agency will be invoicing at the beginning of July for the month of June. The agency needed to expend substantial amount of Emergency Rental Assistance (ERA-2) grant funding (prior to CDBG funding) to meet the needs of clients. Florida Promise plans to meet all program and expenditure goals.

OLD BUSINESS:

Linda discussed with the committee about the Neighborhood RFP Distribution, she requested if the committee can give her names of people that we should send the form out to. She also stated that we are accepting two proposal from each community. The date we are looking for submission will be August 26, 2024.
