

# Save Our Indian River Lagoon Project Plan March 2025 Progress Report

#### WORK COMPLETED THIS MONTH:

- 2025 Update to the Save Our Indian River Lagoon Project Plan was adopted by the County Commission
- Clams Across the Lagoon event celebrated completion of the first 100 projects
- Lessons learned and thoughts for the future from the Citizen Oversight Committee were compiled for discussion
- Citizen Oversight Committee Appointments for the 2025-2027 term were completed
- Quick Connects 31 more reimbursements processed of 443 to date; 527 agreements executed
- Septic Upgrades 21 more reimbursements processed of 370 to date; 624 total agreements executed
- University of Central Florida completed 1 month monitoring at the Banana River Pilot Project that was seeded with gardened oysters at deployment this reef was and had an average oyster density of 198 live oysters per square meter; McNabb Planter Boxes were also monitored survival across all modules is above 70%, but the cement-jute lining is degrading and resulting in erosion of sediment from the planter boxes
- Contracts executed 21-138 Ray Bullard Amendment 3, 23-223 Spring Creek Dredging Amendment 1, Florida Department of Environmental Protection Grants LPA0093, and NS058 Amendment 3
- Derelict Vessels 3 Vessel Removed
