

Save Our Indian River Lagoon Project Plan April 2017 Progress Report

WORK COMPLETED THIS MONTH:

- Position classification descriptions and advertisements were written for Save Our Indian River Lagoon Project Plan
- Continued coordination with municipalities, state officials and the Legislative Delegation regarding matching fund requests and proposed legislation with potential Indian River Lagoon implications
- Developed forms to use with the Municipal Cost-Share Agreements for reporting progress, submitting invoices, certifying payment and calculating cost-share eligibility
- Developed a process for paying sewer connection fees directly so owners don't front that cost
- Developed a notice to proceed process for implementing projects in the Project Plan inhouse
- Revised the Substitute Project Submittal Form to address feedback from the Citizen Oversight Committee and questions from municipalities
- Mims Muck Dredging and Outflow Treatment contractor selected
- Re-allocated a County Baffle Box upgrade grant to municipal substitution projects (see map)

WORK UNDERWAY THIS MONTH:

- Development of the Muck Finder App is underway. Marine Resources Council is recruiting volunteers and gathering supplies. Florida Tech is developing the training tools.
- Coordination with Florida Tech and County Attorney regarding Intellectual Property
 Disclosure and Provisional Patent Application for Ferrate Treatment developed under
 current research contract
- Working with Matt Susin, Brevard County School Board, on projects students can do to support the lagoon restoration efforts starting with rain benches and greenhouses
- City of Satellite Beach video Selected a Year Zero project to highlight and met for interview
- Coordination with the City of Rockledge and their consultant on data collection to measure the success of the Rockledge Breeze Swept Septic to Sewer project
- Worked with representatives of Sebastian Marina on a grant application to St. Johns River Water Management District for the Micco Sewer Extension project. Responded to community inquiries.



- Applied Ecology is building a vector-based online tool for estimating nutrient loading from any area of interest and load reductions anticipated from various stormwater treatments
- Closewaters is researching readily available Economic Valuation metrics and ikons
